Note by the Secretary-General

1. In accordance with article 17 of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, the eighteenth meeting of States parties to the Convention is to be held at the United Nations Office at Geneva on 11 October 2021 for the purpose of electing five members of the Committee against Torture from a list of persons nominated by States parties (sect. II), to replace those whose terms of office will expire on 31 December 2021 (sect. I). Five members will continue to serve on the Committee until 31 December 2023 (sect. III).

2. In compliance with paragraph 12 of General Assembly resolution 68/268, the present note contains information on the current situation with respect to the composition of the Committee, reflecting the balance in terms of geographical distribution and gender representation, professional background and different legal systems, as well as the tenure of current members (sects. I and III). The biographical data of current members can be found on the web page of the Committee (www.ohchr.org/EN/HRBodies/CAT/Pages/Membership.aspx).

3. In paragraph 13 of its resolution 68/268, the General Assembly encouraged States parties, in the election of treaty body experts, to give due consideration, as stipulated in the relevant human rights instruments, to equitable geographical distribution, the representation of the different forms of civilization and the principal legal systems, balanced gender representation and the participation of experts with disabilities in the membership of the human rights treaty bodies.

I am an academic, and have been teaching at the Institute of Human Rights and Peace Studies at Mahidol University in Thailand since 1996. I teach courses on human rights standards and mechanisms, human rights in international relations, and regional human rights systems, among others. I have done research as well as provided academic services to various organizations, including the United Nations treaty bodies and special procedures.

Main professional activities

For many years, my research and advocacy have focused on issues of migrant workers, refugees and asylum seekers. In these contexts, serious human rights issues remain intractable, including harassment and extortion at the hands of local law enforcement officers, prolonged and indefinite detention in immigration detention centres and prisons, etc. To prevent torture by promoting human rights education, I have served as the convener of the ASEAN University Network – Human Rights Education, aimed at inculcating a human rights culture in the region since 2009. From this experience, I have witnessed how international, regional and national legal frameworks have contributed to the alleviation of human rights concerns through evidence-based policy responses, advocacy, and the capacity of rights holders and duty bearers to undertake their commitments.

In 1979, I earned a B.A. in political science from Thammasat University, Thailand. In 1987, I received a D.E.A. in Comparative Politics and in 1992 a Ph.D. in Political Science at the University of Paris X-Nanterre in France (Très honorable). In 1997, I was granted a Diploma in Human Rights and Humanitarian Law, Raoul Wallenberg Institute, Sweden; in 2017 an Honorary Doctorate from the University of Oslo for my contribution to human rights causes.

As an academic, I have been invited to speak at various forums, the latest one being the International Conference on Combating Torture in ASEAN/Southeast Asia during 18-19 June 2021, at which I emphasized the state of torture in the region; efforts made by ASEAN and its members to combat torture; eliminating corporal punishment against children as well as addressing issues regarding death penalty. I have also co-edited human rights and peace articles in a Southeast Asia series which include articles pertaining to issues surrounding torture. I also conducted a research project on the right to life in Southeast Asia focusing on death penalty. Papers based on this research project are being edited for publication by Springer. I have also advocated a child's right to be free from corporal punishment and the right to non-refoulement and legal identity of refugees and asylum seekers.
