Subject: Extension of deadline for applications for four vacancies of EMRIP members to be appointed at the 34th session of the Human Rights Council (27 February-24 March 2017)

1. *Expert Mechanism on the Rights of Indigenous Peoples (EMRIP), member from the Arctic [HRC res. 33/25]*
2. *Expert Mechanism on the Rights of Indigenous Peoples (EMRIP), member from Asia [HRC res. 33/25]*
3. *Expert Mechanism on the Rights of Indigenous Peoples (EMRIP), member from North America [HRC res. 33/25]*
4. *Expert Mechanism on the Rights of Indigenous Peoples (EMRIP), member from the Pacific [HRC res. 33/25]*

For the following three mandates holders also to be appointed at the 34th session, the deadline expired on 24 November 2016 and applications are no longer accepted:

5. *Special Rapporteur on the right to development [HRC res. 33/14]*
6. *Special Rapporteur on the rights to freedom of peaceful assembly and of association [HRC res. 32/32]*
7. *Working Group on Enforced or Involuntary Disappearances, member from Latin American and Caribbean States [HRC res. 27/1]*
