It should be fully completed and saved in Word format and then submitted as an attachment by email. Information provided in this form includes a motivation letter of maximum 600 words. The application form should be completed in English only. It will be used as received to prepare the public list of candidates who applied for each vacancy and will also be posted as received on the OHCHR public website.

Once fully completed (including Section VII), the application form in Word should be submitted to hrcspecialprocedures@ohchr.org (by email). A maximum of up to three reference letters (optional) can be attached in Word or pdf format to the email prior to the expiration of the deadline. No additional documents, such as CVs, resumes, or supplementary reference letters beyond the first three received will be accepted.

I have extensive knowledge of the international human rights system, first as a member of different Latin American solidarity committees with the victims of human rights violations (between 1976 and 1984), then as co-founder of the Plataforma Interamericana de Derechos Humanos, Democracia y Desarrollo (1992), as a member of the international board of the Program on Women's Economic, Social and Cultural Rights (PWESCR, based in Delhi, 2013 until present) and as Latin American representative of Third World Network (1989 until present), an alliance of Southern-based NGOs and researchers that has championed the Right to Development since its creation in 1984.

As coordinator of Social Watch (since 1996) and main author of its yearly report I have actively promoted a rights-based approach to development and I have participated as a consultant in the Fourth session of the High-Level Task Force on the implementation of the right to development (7-15, January 2008) and made the closing remarks on "The Right to Development and the Evolving Global Agenda and Goals for Sustainable Development" during the commemoration of the 30th anniversary of the RtD Declaration at the UN (December, 2014).

Yes I can dedicate significantly more than three months of my time for the mandate. In the remaining time I will also be working, in my capacity as coordinator of Social Watch and a member of the Reflection Group on Sustainable Development on researching, writing and building capacity of civil society groups on Right to Development issues. These activities include the establishment of a regular information flow between the UN system and the public through different initiatives aimed at identifying synergies amongst governments, independent institutions and civil society.

III. MOTIVATION LETTER (600 word limit)

Dear Madam, Sir,

The HRC appointment of an SR on RtD coincides with the launch of the 2030 Agenda.

This Agenda and the other key resolutions of 2015 represent a major paradigm shift in development consensus, as it

- a) identifies poverty as an universal problem (with extreme poverty as the most urgent priority -target 1.1- but incorporating relative poverty in all countries in target 1.2)
- b) recognizes that social progress (in health, education, social protection) needs to take place in a framework of planetary boundaries (climate change, depletion of fisheries, excessive use of chemicals in agriculture),
- c) identifies inequalities as a major global problem and proposes to reduce it within and among countries, as spelled out in goal 10, but also in SDG 5 on gender equality and women empowerment and in multiple references to justice and inequalities,
- d) emphasizes governance issues (peaceful and inclusive societies, access to justice, affective, accountable and inclusive institutions) as inherent to sustainable development.

This new agenda is "grounded in the Universal Declaration of Human Rights (and) it is informed by (...) the Declaration on the Right to Development." (Paragraph 10)

Further, the 2030 Agenda, same as Human Rights, is universal: no country can claim to be sustainably developed and all countries have to make efforts to reach their targets domestically and to achieve global goals that no Member State can meet by itself no matter how powerful. In fact countries from all regions of the world and very different capabilities are volunteering to submit to the UN their progress reports. While non binding legally, the 2030 Agenda is becoming the international standard and thus acquires enormous political weight.

The 2030 Agenda is consistent and compatible with the Right to Development and it shares with RtD its aspiration to a "fair distribution of benefits". The aspirational nature can be seen as "soft law" and therefore limited when compared with legally enforceable rights. But it can also be seen as an opportunity to create synergies between the development agenda and the right to development and to strengthen the global partnership for both.

For more than 20 years I have been working building coalitions to implement ambitious but not legally binding UN resolutions and I know of the obstacles but also of the enormous energies that can be unleashed. As Special Rapporteur on the Right to Development, if appointed, I look forward to working together with international institutions, including those dealing with finances, trade and investment, to mainstream RtD and 2030 Agenda in their policies and to assist governments in their right and duty to formulate programs conducive to sustainable development and the fair distribution of its benefits.

I understand the creation of this mandate as expression of a will of Member States to strengthen accountability mechanisms at all levels, from national and local to global. I have argued consistently that without effective accountability within a framework that understands common responsibilities but differentiated capabilities, implementation will suffer.

The mandate created by Resolution 33.14 is well placed to bring congruence between the two instruments of the 2030 Agenda and the Declaration on RtD. The normative framework of the RtD can offer valuable guidance to international organizations and to states on how to safeguard "policy coherence" in pursuit of the 2030 Agenda, and can help to specify the common but differentiated responsibilities which all countries have to ensure that their policies and actions do not undermine sustainable development and human rights beyond their borders.

For all those reasons I feel confident to submit this application to be the first Special Rapporteur on the Right to Development.
