2. The previous rules and regulations are reflecting specific examples for controlling environmental pollutants as possible.

3. The governmental challenge to address air pollution has been to expand the ambient air quality's network monitoring.

4. In order provide more protecting ways, we suggest that

- To encourage environmentally-friendly vehicles and auto-mobiles.

- To establish a central heating system depending on environmentally-friendly fuel, to provide indoor heat for winter semester demands.
- To increase the green areas in order to filtrate air pollutants as possible, such as the suspended particles and burning released gases.
- To avoid smoking in locations with direct exposure to people, such as indoor clusters, gardens and the crowded areas.
