Dear civil society colleagues,

Please find the attached correspondence, which has been shared today with all UN Permanent Missions. Please feel free to circulate among your networks.

In resolution A/RES/74/148 on the Protection of migrants, which was adopted by the General Assembly on 18 December 2019, the General Assembly emphasizes the importance of protecting persons in vulnerable situations (para. 6) and calls upon States to cooperate internationally to save lives and prevent migrant deaths and injuries, as well as to identify those who have died or gone missing, and to facilitate communication with affected families (para. 6b). The General Assembly stresses the importance of international, regional and bilateral cooperation in the protection of the human rights of migrants, through, inter alia, the Global Compact for Safe, Orderly and Regular Migration (para. 10)

In the aforementioned resolution, the General Assembly requests the Secretary-General to submit to the General Assembly and the Human Rights Council at their seventy-sixth and forty-fourth sessions a comprehensive report entitled "Human rights of migrants", covering all aspects of the implementation of the present resolution (para. 20).

The Office of the United Nations High Commissioner for Human Rights would be grateful to receive relevant information for the preparation of this report, including on:

- Actions taken to advance the protection of migrants in vulnerable situations;
- Challenges and best practices in identifying missing migrants and ensuring access to information and justice to their families;
- Advances in the protection of the human rights of migrants through the implementation of the Global Compact for Safe, Orderly and Regular Migration.
