Obstacles faced by women in accessing the internet, sex disaggregated data on access to the internet and measures to bridge the gender digital divide in Rwanda OHCHR – United Nations

The Rwanda National Commission for Human Rights received a topic from the United Nations Office of The High Commissioner for Human Rights requesting inputs regarding Obstacles faced by women in accessing the internet, sex disaggregated data on access to the internet and measures to bridge the gender digital divide. It is in that regard that the Commission would like to submit its inputs for your further consideration.

1. Sex Disaggregated Data on access to internet

In Rwanda, there is a significant awareness and reasonable penetration to benefit men and women in ICT. Business Development Centers (BDC) and more ICT points are being established in more remote areas. Newly optic fiber and antenna for internet connection are also being installed.

According to ICT Sector Profile 2015, Rwanda's Digital transformation efforts prioritize Governance along with Education, Healthcare, Agriculture, Finance, Trade and Industry as well as Women and Youth empowerment.
